I, the undersigned student, agree to complete the indicated course of instruction by the Safe America Foundation Driving School for the fee as indicated above. It is understood that the Safe America Foundation Driving School is licensed by the Georgia Department of Driver Services (DDS) in accordance with Georgia Law Title 43-13-1 (The Driver Training School and Commercial Driving Training School License Act) and that each instructor has been certified by the Georgia Department of Driver Services.

I understand that the Safe America Foundation Driving School will not refund any tuition, or part of tuition, if the School is ready, willing and able to fulfill its part of this contract. I understand that if I fail to comply with the terms and conditions of this agreement, I am in breach of contract and the school will be under no obligation to fulfill the terms of this contract, and may, at its option, terminate this agreement immediately. Instruction must be completed within six (6) months of the date of this contract.

I understand that the successful completion of the course indicated above does not entitle me to receive a motor vehicle operator's license nor guarantee that I will be successful in completing the requirements for obtaining a driver's license from Georgia or any other state. However, within three (3) business days of successful completion of the 30/10, 30/6 or 30 hour classroom-only course, the Safe America Foundation Driving School agrees to provide certification of said completion to the student if the required minimum hours have been completed.

The Safe America Foundation Driving School has and will maintain, for the protection of the contractual rights of the student, a performance bond in the principal sum of twenty-five hundred (\$2,500) dollars for the students to be written by a company authorized to do business in the State of Georgia.

CANCELLATION POLICY

Cancellations made 14 calendar days or more before the first classroom instruction date will receive a full refund of tuition paid, less a \$50 processing fee. Cancellations made 7 to 13 calendar days before the first classroom instruction date will receive a 75% refund. Cancellations made less than 7 calendar days before the first classroom instruction date will forfeit the paid tuition and will not be able to transfer this enrollment to any other session.

Behind-the-Wheel Training Cancellation Policy: Appointments must be cancelled at least 24 hours in advance or the student forfeits the lesson and any fees associated with the lesson. When a student is ten minutes or more late for a driving lesson the lesson may be rescheduled at the instructor's convenience and the student assessed additional fees. Make-up lessons are assessed a \$40 charge. Make-up lessons must be completed within sixty (60) days from the previous lesson. No refund is given for missed lessons. Hours are not transferable between students. Missed time will not be refunded. No Behind-the-Wheel Driving instruction will be given in hazardous weather.

By signing this agreement I acknowledge that I have received, read and understood the rules and cancellation policy of the Safe America Foundation Driving School. Any violations of any rules or regulations will result in forfeiture of scheduled time and fees.

By signing this contact student/parent/guardian agree to the following conditions:

- 1) All fees must be paid before beginning any training course.
- 2) A \$45 fee will be charged for any returned checks or disputed charges.
- 3) A class requires a minimum of eight (8) students. If a course is cancelled, the student will be rescheduled.
- 4) Attendance for all thirty (30) hours of classroom instruction is required for successful completion of the full driver training courses. Absences must be made up. An absence of more than eight (8) hours of the scheduled classroom instruction will require the student to repeat the entire course at the next available session. An additional fee of \$75 will be assessed.
- 5) Completion of a written or oral examination with a grade of at least 70% for the in-class instruction and/or driving lesson is required for successful completion of the course, or portion thereof.
- 6) The student will adhere to the Safe America Foundation dress code policy both in the classroom and during driving sessions. Proper attire is that considered appropriate for a school classroom. Inappropriate attire includes dirty clothing, t-shirts with offensive language, flip-flop sandals, and provocative clothing such as halter tops, mini-skirts and spaghetti-strap blouses. Failure to comply with the dress code policy could result in dismissal from class or cancellation and forfeiture of driving lesson.
- 7) The student must present a valid Georgia permit or license to begin the on-the-road driving segment.
- 8) Each driving session must consist of a minimum of two (2) hours, commencing at scheduled time.
- 9) No passengers, snacks, cell phones, cameras, or electronic devices are allowed during on-the-road instruction.
- 10) The student releases the Safe America Foundation Driving School, its agents or employees, from all liability including traffic violations, injury, damages, or claims which the student may suffer or incur arising out of any act, restriction or omission in the Driver Education Program, except by reason of gross negligence of such persons.
- 11) Students are permitted to operate Driving School vehicles ONLY under instructor supervision.
- 12) Traffic violations are the responsibility of the student and his/her actions. Student will not hold Safe America Driving School or its agents responsible for any traffic violation during highway instruction.
- 13) Any type of behavioral problem will result in dismissal from the course. The full tuition will be forfeited.

The Safe America Foundation Driving School agrees to the following conditions:

- 1) Provide use of a school's vehicle for the actual driving instruction without additional cost.
- 2) Begin and end the driving segments at the location of the classroom instruction.
- 3) Maintain insurance to protect the student.

This agreement constitutes the contract between the school and the parent/guardian and no verbal statements will be recognized.
